

**“Vegas Suite Life Sweepstakes”
Official Rules**

1. **SPONSOR:** Speedway Properties Company, LLC., 5555 South US HWY 29, Concord, NC 28027 (“Sponsor”).
2. **WHO CAN ENTER? NO PURCHASE NECESSARY:** Open only to legal residents of the 50 United States and the District of Columbia 21 years of age or older. Employees of Speedway Motorsports, Inc., The Performance Racing Network, WIX Filtration Corp LLC, Cooper Tire & Rubber Company, Atlanta Motor Speedway, Inc., Bristol Motor Speedway Inc., Charlotte Motor Speedway, LLC aka Lowe’s Motor Speedway, Las Vegas Motor Speedway Inc., Speedway Sonoma, LLC aka Infineon Raceway, Texas Motor Speedway Inc, NASCAR, its advertising and promotion agencies, their respective parent companies, affiliates, agents, retailers, subsidiaries, sales representatives and/or distributors and their immediate families, (parents, children, spouse, siblings) and those living in the same household (whether related or not) as such individuals are not eligible. A credit card is required for hotel check-in. A form of government-issued photo identification is required for air travel and Event registration.
