

**“Rock Star Race Fan”  
Official Rules**

1. **SPONSOR:** Speedway Motorsports Inc., PO Box 600 Concord, NC 28026 (“Sponsor”). Sweepstakes is sponsored by a number of different companies and will be offered in a number of different presentations.
  
2. **WHO CAN ENTER? NO PURCHASE NECESSARY:** Open only to legal U.S residents 21 years of age or older.
